DIRECTIONS FOR USE: MOP-ON APPLICATION

1. Sweep floor using a mop treated with EnviroStar Green® Dust Mop Treatment or an untreated dust mop.
2. Autoscrub floor with a Pioneer Eclipse neutral cleaner prior to the application of Extend Auto-Burnish Floor Maintainer. Dilute the cleaner according to the light cleaning directions on the label of the cleaner. Use a Pioneer Eclipse light cleaning pad on the autoscrubber.
3. Mix Extend Auto-Burnish Floor Maintainer in a mop bucket per the following dilution ratio:
1:64 2 US oz per gallon water (80 ml per 5 liters water)
4. Apply the solution with a clean synthetic mop.
5. Allow floor to dry thoroughly.
6. Burnish with recommended Pioneer Eclipse machine and pad.

NOTE: Do not use Extend Auto-Burnish Floor Maintainer more than twice a week or as a scrubbing cleaner. Do not apply Extend Auto-Burnish Floor Maintainer with an autoscrubber.

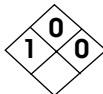
