- 1. Dust mop floor with an untreated dust mop.
- 2. Mix EnviroStar Green All Purpose Cleaner in mop bucket or autoscrubber per the following dilution ratios:

Light Cleaning

1:256 0.5 US oz per gal cold water (20 ml per 5 liters water)

Medium Cleaning

1:128 1 US oz per gal cold water (40 ml per 5 liters water)

Heavy Cleaning

1:64 2 US oz per gal cold water (80 ml per 5 liters water)

Damp mop or autoscrub floor with Pioneer Eclipse light cleaning pad.

DEEP SCRUB MAINTENANCE:

- 1. Dust mop floor with an untreated dust mop.
- Mix EnviroStar Green All Purpose Cleaner in mop bucket or autoscrubber per the "Heavy Cleaning" dilution indicated above.
- Wet mop or autoscrub with a Pioneer Eclipse deep scrub pad. Rinse floor with clean cold water and allow to dry.
- 4. Recoat with EnviroStar Green Floor Coating.
